Egyptian eInvoice

"One of the most important key projects in Egyptian Tax Authority Digital Transformation journey, is the <u>eInvoice System</u>"

- Reducing and integrating the informal economy.
- Controlling total tax evasion.
- Oversee and control all commercial transactions.
- Achieve equality and tax justice.



What is Egyptian eInvoice?

A Comprehensive centralized solution, that act as verification and compliance point for all the B2B transactions across the country, incorporating all the goods, services, and trading between economical entities.

Egyptian eInvoice position in the region

Egyptian eInvoice is now a very important rolemodel being followed / imitated by many countries in the region, supporting and providing knowhow to many neighbor countries.



Beyond Invoice

MoF is finalizing the eReceipt system, to complement the B2B with the B2C transaction using PoS to complete the supply chain cycle. eInvoice is now a key compliance entry with:-- Business trading / Service transaction,

- Importers / Exporters,
- Dealing with all government entities (B2G),
- Utilizing investment facilities,
- Tax refund,
- Tax audit, etc...



eInvoice – eReceipt – Incentives

- eInvoice is for B2B transactions (Business to Business)
- eReceipt is for the B2C transactions (Business to Consumer)
- Incentive system is to encourage citizen and consumers to request for the sales receipt to protect their rights and reveal potential evasion.

eInvoice and Financial Inclusion

- "Financial inclusion aims to develop the financial literacy level among consumers, improve their financial capabilities, develop innovative financial products that meet their needs, and establish strong frameworks for consumer protection for those dealing with the financial and banking sector" (CBE-Financial Inclusion Strategy) - "By 2025, Issuing all transactions will be through eInvoice / eReceipt, followed by Payments through digital payments / PoS'' (MoF).

e-Economy

- Looking back to Egypt 2030 vision, all the economic entities will be using B2B/B2C.
- All transactions will be monitored by ministry of finance, paid by digital payment, monitored by CBE.
 Citizens and consumers will be much aware about their rights and the benefit of formal economy.

Digital taxation and Digital Payments are pillars to achieve e-Economy & Financial Inclusion
